4	Q	<p>We have a question concerning who can present during the oral presentations. RFP Page 63, Paragraph 3.1 (c) states, "The individuals proposed to present the oral presentations must be key personnel." RFP Attachment 8, Paragraph 5 states, "Only individuals proposed as key personnel, whether from the prime or subcontractor and other participants must be from the pool envisioned to be employed on the contract, shall participate in the presentations." Our question is does the phrase "and other participants" allow non-key personnel to be presenters at the oral discussions as long as they are envisioned to work on the contract? Thanks for your time and consideration on this question.</p>
	A	<p>Typically, only key personnel will allow presenting during the oral presentations. Since we only have 2 key personnel for this solicitation, here is the clarification for oral presentations:</p> <ol style="list-style-type: none"> 1. The individuals proposed to present the oral presentations must be key personnel. 2. Additionally, we allow "other participants" such as non-key personnel to be presenters at the oral presentations as long as they are envisioned to work on the referenced contract. 3. When request by the Government, you must be able to provide proof of employment for the "other participants", i.e., letter of intent/acceptance of employment, written contract and etc.
